This limited five-year warranty includes all components except for all electrical components which carry a limited warranty of one year. After installation, if covered components manufactured by Himark Innovative Products Inc. are found to be defective in materials or workmanship during the appropriate warranty period and while the product remains at the site of the original installation, Himark Innovative Products Inc. will, at its option, repair or replace the covered components. Himark Innovative Products Inc. reserves the right to replace covered components with an equivalent product and the replacement must be carried out in accordance with Himark Innovative Products Inc. recommendations. If replacement is not commercially practical, Himark Innovative Products Inc. will, at its option, refund the purchase price or wholesale price of the Himark Innovative Products Inc. product, whichever is applicable. THERE ARE EXCLUSIONS AND LIMITATIONS to these warranties as described herein.

Coverage commencement date.

Warranty coverage begins on the date of installation.

Exclusions and limitations.

These warranties apply only if the product is installed in the United States or Canada and only if used for the application for which it was designed and intended. The product must be maintained in accordance with the printed instructions accompanying the product and in compliance with all applicable installation and building codes and good trade practices. This warranty is non-transferable.
